



# RELEASE of LIABILITY AGREEMENT

I, the undersigned, understand that Hawaii Law (Act 249, 1994 Hawaii Legislative Session, effective June 29, 1994/HRS 6638) limits the civil liability of persons sponsoring equine (horse, pony, mule, donkey, or hinney) activities. I understand that there are inherent risks of injury, including death, when participating in an equine activity, which risks include but are not limited to (1) the propensity of an equine to behave in ways that may result in injury or death to persons on or around them, (2) the unpredictability of an equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals, (3) hazards such as surface and sub-surface conditions, (4) collisions with other equines or objects, and (5) the potential negligence of another participant, such as failing to maintain control over the equine, or not acting within the participant's ability.

I acknowledge that I have read and understand this agreement. I further acknowledge that I know and understand the risks of participating in an equine activity, including injury and/or death and damage to personal property. I expressly choose to assume these risks (or, if signing on behalf of a minor or any other person, to assume these risks on the minor's behalf). Further, on behalf of myself and/or the person on whose behalf I sign, our heirs, successors, personal representatives administrators, representatives, and assigns, I and person on whose behalf I sign hereby unconditionally release any and all claims and causes of actions against the following equine activity sponsors: Fronda Harris, Anthony Harris, Heart Ranch, and its landowners, lessors, shareholders, officers, directors, principals, employees, agents, representatives and any other personnel, for injury including death, and for any damage to personal property, which I or the person on whose behalf I sign may incur as a result of my and/or the person on whose behalf I sign's participation in this equine activity.

If the undersigned is the parent, guardian of representative of any minor participating in this Equine Activity, the undersigned agrees to indemnify the above described equine activity sponsor (including its/their above described persons and entities) from any and all claims and causes of actions brought by or on behalf of said participant at any time. The undersigned agrees that this instrument is binding and includes his/her heirs, personal representatives, administrators, representatives, and assigns.
